I am an experienced arbitrator, mediator, and commercial/civil litigator. I have been practicing law since 1993. My expertise encompasses banking, contractual, commercial, shareholder, business and family enterprise disputes and insolvency issues.

I have received the following credentials. Fellow of the Chartered Institute of Arbitrators (FCI Arb); Qualified Arbitrator (Q. Arb) and Qualified Mediator (Q. Med.) by the ADR Institute of Canada.

Since 2021 I have been appointed to arbitrate as sole *ad hoc* arbitrator for commercial, business, and contractual disputes. I have expertise in running virtual and in person proceedings.

Since 2011, I have also mediated disputes involving business relationships, contracts, negligence, failed transactions, real estate development and transactions, insolvency, fraud, employment, lottery winnings, hockey ticket subscriptions, supplier disputes, international transactions, family business succession issues and other legal issues.

In my legal practice, I have represented clients at arbitration and court proceedings. My work as a lawyer and practice encompassed representing, financial institutions, insurers, business owners, shareholders, companies, creditors, debtors, court appointed officers and individuals in commercial litigation and insolvency matters. My legal experience encompasses representing parties in commercial litigation and insolvency proceedings on many kinds of matters including, contractual disputes, enforcing contractual and/or statutory rights, pursuing shareholder and oppression remedies, determining priorities, pursuing fraudulent actors, tracing funds, obtaining injunctive relief including orders to preserve and freeze property, setting aside fraudulent conveyances or preferential transactions and asserting property rights and appointing receivers and trustees. I have also represented court officers in the context of court appointed receiverships that involved locating assets, running claims and sales processes, obtaining approval and vesting orders, tracing funds, approving distributions or commencing litigation, and providing legal opinions.

Through my litigation and dispute resolution work, I have had a wide focus and exposure to many industries including finance, banking, insurance, real estate development and sale, construction, professional services, medical services, research and development, technology development, logistics, automotive manufacturing and sales, restaurant and hospitality, manufacturing, retail sales and mining.

Arbitration

I have been appointed as sole *ad hoc* arbitrator in commercial disputes. In this capacity I have run arbitral proceedings from the preliminary meeting and case conference, through evidence exchange, document disclosure issues, hearings, consideration of fact and expert witness evidence and legal submissions and writing arbitral awards. These arbitrations involved businesses and people in many different industries including finance, insurance, medical, scientific research, and hospitality. Some of the legal issues that I considered were jurisdiction, contractual interpretation, breach of contract, breach of good faith, triggering events, oppressive conduct, accounting and documentary disclosure, misrepresentation and assessing damages. I have also represented parties at arbitration.

Mediation

Since 2011, I have been appointed to mediate a variety of disputes, including disputes between business partners, shareholders, suppliers, manufacturers, parties to a sale transaction, creditors, estate beneficiaries, employers and employees and family members. The issues included contract interpretation and enforcement, business operations, breach of contract, negligence, misrepresentation, fraud, bad faith, conflict of interest, succession plans, employment, torts, and estate issues. I have also facilitated business meetings over several months and communication workshops for enterprising families looking to avoid litigation and preserve or repair relationships.
