Alina Leoveanu is a senior legal consultant in the International Arbitration practice of the Paris office.

She represents companies in commercial arbitrations and mediations in complex disputes arising from different economic sectors and industries.

Alina has been a CEDR Accredited Mediator since 2016, a member of the ICC Commission on Arbitration and ADR since October 2019 and has been recently appointed as an ArbitralWomen Board member for the 2022-2024 term.

Prior to joining Mayer Brown, Alina was the Manager of the ICC International Centre for ADR ("Centre") and was responsible for the ICC's ADR services, which include mediation, expert appraisal and dispute board proceedings, in addition to banking related disputes.

Alina also served as Global Co-Chair of the ICC Young Arbitrators Forum from September 2016 to July 2019. She regularly represented the ICC at conferences across the world.

Prior to being the Manager of the Centre, Alina was a part of the Secretariat of the ICC International Court of Arbitration as a Deputy Counsel for the Central and Eastern European Team. Alina oversaw hundreds of arbitration proceedings, assisted the ICC Court, scrutinized arbitral awards and acted as a liaison between parties, counsel and arbitral tribunals.

Before joining the Secretariat of the ICC International Court of Arbitration, Alina worked as a case processing lawyer at the European Court of Human Rights in Strasbourg, France.

In addition to her native Romanian, Alina is fluent in English, French and has a good understanding of Spanish.

Experience

Recent or pending arbitration, mediation or court proceedings in which Alina Leoveanu was involved include the representation of:
