## Professional Experience

Anastasia has led engagements and supported testifying experts to assess damages and complex valuation issues in international arbitration. She has extensive experience in the quantification of lost profits, wasted costs, the valuation of assets or other damages in various industries, including manufacturing, retail, hospitality, advertising, real estate. She frequently assesses claims of prolongation, disruption, variations and well as other claims of a financial nature in the context of construction disputes, often regarding facilities of O&G, nuclear, renewable energy, processing plants and other infrastructure.

Anastasia has been involved in over 25 disputes, including in arbitration proceedings before ICC, UNCITRAL, VIAC, LCIA and ADCCAC, as well as multiple damages assessments in a pre-arbitration or negotiation setting. The value of the damages assessed typically ranged between €10 to €200m, with claims in several cases exceeding the value of €500m.

Anastasia has a very international profile, having worked in Accuracy's Milan, London and Paris offices and dealt with engagements in Europe, CIS, Middle East, South America and North Africa. She is leading Accuracy's Eastern Europe & CIS Competence Center, often being involved in cases regarding this region.
